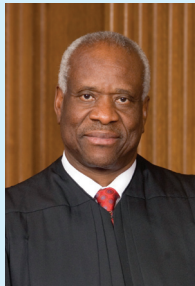


Our Mission

Executive overreach in areas such as health care, environmental protection, and immigration enforcement has created an extraordinary number of litigation opportunities. The Center takes advantage of these opportunities by pursuing litigation from initial complaint all the way through to Supreme Court review.

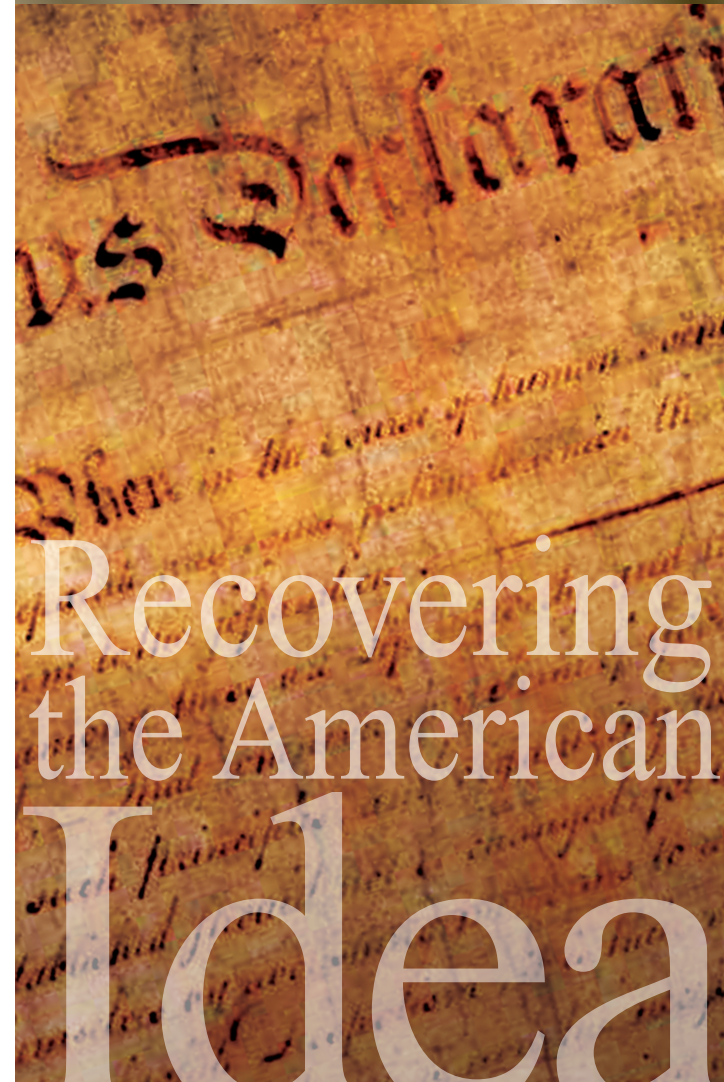
